

INFORMATION CLAUSE ON PROCESSING OF PERSONAL DATA OF PARTICIPANTS OF THE ONLINE TRAINING "IDEA UP"

In accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR), Wrocław University of Science and Technology informs that:

- 1. The controller of the personal data of the participants of the online training is Wrocław University of Science and Technology, located at Wybrzeże Wyspiańskiego 27, 50-370 Wrocław, NIP: 896-000-58-21, REGON: 000001511.*
- 2. The personal data of the participants of the online training IDEA UP will be processed for the purpose of enabling participation in the training, informing the participants about current matters related to the training, enabling access to training materials, and issuing a certificate of completion of the training. Personal data will be processed on the basis of Art. 6(1)(b) of GDPR.*
- 3. Personal data is processed by Wrocław University of Science and Technology and partner institutions such as University of La Laguna (Spain), FIR Aachen GmbH (Germany), CRIT Srl (Italy), and Holon Institute of Technology (Israel), including authorized employees and collaborators of these institutions.*
- 4. Participants of the online training IDEA UP are informed that personal data will be transferred outside the European Economic Area to Israel, as well as to other countries where it is necessary for the implementation of the online training purposes. In such cases, the transfer of personal data is carried out in accordance with applicable laws, including GDPR.*
- 5. The personal data of the participants of the online training IDEA UP will be stored for the period necessary for the processing purposes and to comply with legal requirements, no longer than 5 years.*
- 6. Participants of the online training IDEA UP have the right to access their personal data, rectify, delete or limit processing, and the right to data portability. Participants also have the right to lodge a complaint with the supervisory authority.*
- 7. Participants of the online training IDEA UP provide their personal data voluntarily, however, failure to provide them will make it impossible to participate in the training.*
- 8. The personal data of the participants of the online training IDEA UP will be processed in accordance with the principles set out in GDPR and other applicable laws.*
- 9. No automatic decisions, including decisions resulting from profiling, will be made as part of the processing of personal data of the participants of the online training IDEA UP.*
- 10. The information clause may change, therefore participants of the online training IDEA UP are requested to regularly check the content of the clause on the website of the training organizer.*
